WAIVER, RELEASE AND INDEMNITY AGREEMENT

The parent(s) of participant(s) must complete and return this agreement. It is understood that I (the participant), cannot participate in Basketball Practices Workout Sessions and Tournaments until this Waiver form has been completed. Coaches are responsible for obtaining signatures of the parents/guardian of each participant.

For and in consideration of permitting **my child (participant)** to participate in **Swift Girls Basketball Practices, Workout Sessions and Tournaments** organized and sponsored by The Swift Girls Basketball Program, the Undersigned hereby voluntarily forever releases, discharges, waives and relinquishes any and all action for personal injury, property damage, including travel to and from related events and activities of the Swift Girls Basketball Practices and Tournaments or wrongful death occurring to the Undersigned arising out of the participation in said sport of basketball or any activities incidental thereto wherever or however the same may occur and for whatever period said activities may continue, and the Undersigned does for himself/herself, his/her heirs, executors administrators and assigns hereby release, waive, discharge and relinquish any action or causes of action, aforesaid, which may hereafter arise for himself/herself and for his/her heirs, executors, administrators or assigns shall not prosecute or present any claim for personal injury, property damage or wrongful death against the Swift Girls Basketball Program or any of its officers, agents, volunteers, servants or employees (hereinafter referred to as "Releases") for any of said causes of action including, but not limited to, losses caused by the passive or active negligence of the Releases.

The Undersigned acknowledges, understands and assumes the risks inherent in recreation activities that said activities entails risks of [physical injury to his/her person and property and the Undersigned is participating with full knowledge of said risks.

The Undersigned acknowledges, understands and assumes the risks, if any, arising from the conditions of the various recreation facilities, softball fields and adjacent school, high schools facilities or park grounds and parking lots; and acknowledges and understands that this waiver includes, but is not limited to any action or cause of action arising from (1) the performance, or failure to perform, maintenance, inspection, supervision, control or security of said area (2) for the failure to warn of dangerous conditions as existing on/or near said locations, or (3) for any action by the spectators or (4) for negligent supervision or selection of officials, spectators, players or coaches or (5) for any hidden, latent or obvious defects or dangerous conditions existing on/or near said locations.

IT IS THE INTENTION OF MY CHILD (PARTICIPANTS NAME MUST BE PRINTED) BY THIS INSTRUMENT TO EXEMPT AND RELIEVE RELEASEES FROM LIABILITY FROM PERSONAL INJURY, PROPERTY DAMAGE AND WRONGFUL DEATH CAUSED BY THE PASSIVE OR ACTIVE NEGLIGENCE OF THE RELEASEES.

The Undersigned, for himself/herself, his/her heirs executors, administrators or assigns agrees that in the event any claim for the Undersigned's personal injury, property damage or wrongful death shall be [prosecuted against Releasees he/she shall indemnify and save harmless Releases from any and all claims of action by whomever made or presented for the Undersigned's personal injuries, property damage or wrongful death.

The Undersigned acknowledges that he/she has read the foregoing Paragraphs, has been fully and completely advised concerning same and is fully aware of legal consequences of signing this document. Based upon my independent evaluation of the risks, I REAFFIRM MY ASSUMPTION OF THE RISKS AND DANGERS SET FORTH ABOVE.

I have read and hereby agree to abide by The Swift Girls Basketball Program and Tournaments Activity Rules. I further acknowledge that my participation in the Swift Girls Basketball Program and Tournaments Activities will be in jeopardy should I fail to adhere to the rules. Furthermore, we give our permission to have our child (participant) treated in the event of accident or illness. All participants must have their own private insurance before joining the Swift Girls Basketball Program and Tournaments.
